#### TO: State Agency Head or Emergency Preparedness Manager

The Alabama Emergency Management Agency (AEMA) and the Alabama Department of Public Health (ADPH) are releasing the State Agency All-Hazards/Pandemic Influenza Continuity of Operations (COOP) Plan integrated template. As many of you know, the Honorable Governor Bob Riley released a memorandum on April 10, 2009, directing all state agencies to initiate and complete COOP Plans. In response to this directive, AEMA and ADPH in collaboration with the University of Alabama at Birmingham (UAB) created an integrated COOP template that meets FEMA and CDC guidelines.

There are many FEMA publications that have been released with guidance for developing an effective continuity plan. The Governor stated that the State of Alabama has elected to use FEMA's Continuity Guidance Circular 1 (CGC 1) as the basis for developing COOP Plans. In addition to the release of this template and the FEMA guidance materials, AEMA, ADPH, and UAB will develop a series of 20-minute webcast sessions that will soon be available for viewing on the ADPH and/or AEMA websites. ADPH staff is also available to conduct a one hour live presentation regarding Pandemic Influenza, Personal Preparedness, and Do 10 Fight the Flu campaign.

For scheduling purposes, the state agencies have been divided into tiers. Please see the enclosed attachment. The tiers are based on the agency's essential emergency functions in the State of Alabama and on their participation with ADPH in Pandemic Influenza planning in the past. Each tier has been assigned a tentative COOP development/update completion date that is synchronized with the CDC's annual deadline (tentatively July 31, 2010) for the submission of state COOP and PI Operational Plans. Completed or updated COOP plans should be submitted to AEMA by the completion date for the agency's tier level. AEMA and ADPH will review all plans and provide comments to the agency.
