**A Cooperative Working Agreement
Among Ocean Common Carriers**



ARTICLE 6 - (Continued)

6. The parties hereby authorize their counsel, Preston, Thorgrimson, Ellis & Holman, from time to time as may be necessary, to execute on their behalf, amendments to this agreement reflecting the withdrawal of members.

ARTICLE 7 - MEMBERSHIP, WITHDRAWAL, READMISSION AND EXPULSION

1. Any operator of containerships providing scheduled common carrier service in international commerce may become a party to this agreement and a member of the Council by signing a copy of the agreement which will be provided upon request.

2. This Council shall be composed of one representative from each carrier member who shall be the chief executive officer, managing director or other person at the highest management level of the carrier member.

3. Any member may withdraw from this agreement by giving written notification to the Chairman.

ARTICLE 8 - VOTING

1. This agreement may be amended by the affirmative vote of a two-thirds majority of the Council members.

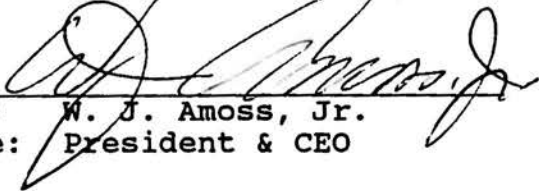
2. Members of the Executive Committee, as specified in Article 6, shall be elected by majority vote.

3. Any agreement entered into by members of the Council will only bind those members who elect to be parties to such an agreement.

ARTICLE 9 - DURATION

This agreement shall become effective concurrently with the effective date of the U.S. Trades Addendum to this agreement and will continue in full force until terminated by action of the members of the Federal Maritime Commission.

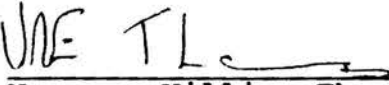
